## YEAR-END GIVING GUIDELINES

IF YOU ARE CONSIDERING A GIFT BEFORE THE END OF 2023, HERE ARE SOME KEY DATES AND FACTORS TO KEEP IN MIND ...

#### GIFTS MADE BY CHECK

THE IRS STATES THAT THE U.S. POSTAL SERVICE POSTMARK DATE SERVES AS THE OFFICIAL GIFT DATE FOR DONATIONS MADE BY CHECK AND SENT THROUGH U.S. MAIL. GIFTS WILL BE CREDITED IN 2023 PROVIDED BOTH POSTMARK AND CHECK ARE DATED NO LATER THAN DECEMBER 31, 2023.

PLEASE NOTE THAT THE IRS DOES NOT GIVE THE SAME TREATMENT FOR POSTMARKS PROVIDED ON DELIVERIES MADE BY CARRIERS SUCH AS FEDERAL EXPRESS, UPS, ETC.

#### **GIFTS MADE BY CREDIT CARD**

A GIFT BY CREDIT CARD IS COMPLETE ON THE DAY THE CARD IS CHARGED. THE GIFT IS DEDUCTIBLE IN THE YEAR THE CHARGE IS MADE. IF YOU CALL OR SEND DIRECTIONS IN A LETTER TO CHARGE A CREDIT CARD IN AN ENVELOPE POSTMARKED IN 2023, BUT THE UNIVERSITY IS NOT ABLE TO PROCESS THE CHARGE UNTIL AFTER THE FIRST OF THE YEAR, THIS GIFT IS NOT CONSIDERED DEDUCTIBLE IN 2023.
